Description:

- 1. Launch of the 2nd circle of the National Policy on the Elimination of Child Labour and its National Action Plan
- 2. Conduct a National Child and Forced Labour Survey in collaboration with the International Labour Organisation (ILO).
- 3. Development of a Child Labour Monitoring and Remediation System (CLMRS) in Supply Chains
- 4. (a) Strengthening Conditional Cash-transfer Programme of the Federal Government to prevent an increase in Child Labour in Supply Chains (Granite Quarry, Rice Farming, Artisanal Gold Mining and Cocoa Farming) by empowering 350,000 vulnerable Households / Child Labour victims.

(b) Rapid Result Cash Register (RRCR) launched on 19 January 2021 for additional 1 Million Households of 4 persons each (4 Million persons to benefit) of Urban Poor and Vulnerable People. This is in addition to the World Bank assisted Conditional Cash-Transfer Register (CCTR) of 2.5 Million Households (total of 10 Million persons) already benefiting as part of the ongoing Nigeria Social Investment Programme (NSIP) being managed by the Ministry of Humanitarian Affairs, Disaster Management and Social Development.

Implementation plan:

- January June: Advocacy visit by the Permanent Secretary (Mr Alliance) to at least one state in each of the six geo-political zones of the country on Elimination of Child Labour
- January June: Advocacy Visit by the Honourable Minister of Labour and Employment on Elimination of Child Labour to at least one state in each of the six geo-political zones of the country on Elimination of Child Labour.
- October 2020 January 2021: Series of virtual meetings on the preparation for the Review, and assess the implementation of the National Policy on Child Labour and the National Action Plan for the Elimination of Child Labour (2013-2017 21)
- January 2021 April: Review, Develop, Validate the 2nd circle of the National Policy on the Elimination of Child Labour and the National Action Plan for the Elimination of Child Labour (2021-2025)

- April: National Launch of the IYECL in Nigeria
- June-August: National Launch of the 2nd circle of the National Policy on the Elimination of Child Labour and the National Action Plan for the Elimination of Child Labour (2021-2025)
- June: Join the global community and social partners to commemorate World Day against Child Labour by organizing series of activities and programmes.- Hosting of a National Children Parliament to discuss child labour issues, government interventions and possible solutions
- November: Develop a Child Labour Monitoring and Remediation System (CLMRS) in Supply Chains.
- June-December: Conduct a National Child and Forced Labour Survey in collaboration with International Labour Organisation (ILO).
- December: Empower 350,000 vulnerable Households / Child Labour victims through the Conditional Cash-transfer Programme of the Federal Government to prevent an increase in Child Labour in Supply Chains (Granite Quarry, Rice Farming, Artisanal Gold Mining and Cocoa Farming).
- December: Register and empower an additional 250,000 households of 4 persons each of Urban Poor and Vulnerable People through the Rapid Result Cash Register (RRCR) of the Government of Nigeria and World Bank assisted Conditional Cash-Transfer Register (CCTR).

Impact:

- Through advocacy and awareness creation, members of the public will get to know more about the ills of child labour and the need for its elimination from society. It will also increase awareness amongst the populace of the physical and psychological effects of child labour.
- The National Policy on Child Labour and its Action Plan as well as the Survey will give the needed legal framework and a coordinated roadmap to fighting child labour in Nigeria. It will also guarantee efficient use of resources.
- 600,000 rural and urban vulnerable households will be empowered through the various Social Investments programmes to prevent an increase in Child Labour in supply chains (Granite Quarry, Rice Farming, Artisanal Gold Mining and Cocoa Farming) and other worst forms of Child Labour as identified.
- Effective collaboration with the Ministry of Humanitarian Affairs, Disaster Management and Social Development, the coordinating Ministry of Nigeria Social Investment Programme (NSIP) to empower an additional 250,000 Household of 4 persons each of Urban Poor and Vulnerable People through the Rapid Result Cash Register (RRCR) of the Government of Nigeria and World Bank assisted Conditional Cash-Transfer Register (CCTR) by December 2021.
